- · Must clear a review of your criminal record and police contact history prior to acceptance
- · Total time commitment: 35 hours over 10 weeks
- Classes meet on nine Thursdays from 6:30 p.m. to 10 p.m.
- Graduation is on a Saturday from 8:30 a.m. to 12:30 p.m.
- Class locations rotate around to police facilities throughout the county
- · Due to the popularity of this class, you're asked to commit to attending at least eight of the 10 sessions
- · No transportation provided
